1. Photographs should feature Orange County wildlife, natural resources, landscapes, or people within our farms, parks and trails.
2. All photos must be taken in a natural setting (no staged photos.)
3. All photos must be taken in Orange County, NC.
4. Orange County employees are eligible with the exception of DEAPR staff, contest judges are ineligible.
5. Entries per person: Maximum of five (5) total photos.
6. Complete and submit one Contest Entry Form for each photo entered. Forms found under "Breaking News" at <http://orangecountync.gov/deapr/>
7. Complete an Orange County Photo Images, Motion Picture and Television Release Form for any third party whose image appears in your photo(s).
8. Each photo must be submitted in an electronic version either by email or by mailing a CD or DVD to Orange County DEAPR. Limit file formats to high resolution .gif and .jpg files (identifiable by their extensions).
